## Dartmouth Hall is Occupied!



With a comprehensive restoration of Dartmouth Hall nearly complete, employees of the Leslie Center for the Humanities and several foreign

language departments have started moving into this iconic building. One unique aspect of this project is that it was funded largely by > 1,000 women alumnae. Dartmouth [Trustee Beth Cogan Fascitelli '80](#) explained, "We want the next generation of students, male and female, to know that women and men are equally committed to the power of a Dartmouth education."

The restoration included preserving the historical building exterior while renovating the interior space, providing classrooms with state-of-the-art technology and flexible format, installing air conditioning, and addressing deferred maintenance needs. The building's heating infrastructure has also been converted from steam to hot water to help meet Dartmouth's sustainability goals. Most importantly, the building's landscape, walkways, and interior are now accessible for all.

When asked what she loved most about this project, Project Manager Lindsay Walkinshaw said, "I love many of the design aspects. I love that there are now public spaces, not just faculty offices, that face the Green. I love the floor-to-floor connection at the stairwells and, of course, I love that the entire building is accessible."

In addition to Lindsay and many other Campus Services employees who worked on this project, credit should be given to Sr. Project Manager Chad Morig who stewarded the project through design, permitting, and construction start. Thanks to so many, the revitalized Dartmouth Hall will serve Dartmouth students for decades to come.
